## Things to note

- Our classes are free and exclusive to Washington State County Assessor's Office staff, related government affiliates, and Department of Revenue employees.

- Appraisal classes offer continuing education (CE) hours and general interest (GI) hours are provided for all other topics. Up to three new GI hours may be applied to accreditation renewals and are not eligible to be "carried over."
- To receive continuing education credit for accreditation, students must attend this amount of the scheduled time:
  - 83% for Department of Revenue classes.
  - 90% for International Association of Assessing Officers classes.
- The law prohibits partial credit. To meet attendance requirements, block the class on your calendar and adjust your workload in advance.
